Background and process

Members of the Administrative Rules Review Committee (ARRC) requested that the Legislative Services Agency (LSA) review legislation enacted during the 2020 legislative session for rulemaking implications and submit a report to the ARRC on its findings. To implement this request, bill drafters in the LSA's Legal Services Division individually analyzed each enacted bill that they drafted for rulemaking implications. The analysis included an examination of each enacted bill within its statutory context as well as any existing rules relevant to the bill. The analysis of each enacted bill was set out in a chart detailing the rulemaking implications for that bill. These charts were then reviewed, revised, standardized, and compiled by ARRC staff. ARRC staff then prepared this report and its accompanying appendices, which summarize the findings of those analyses.

Limitations of LSA rulemaking analysis

It should be emphasized that the LSA does not have the legal authority to make definitive determinations regarding rulemaking by executive branch agencies. It is the responsibility of an agency that has been delegated rulemaking authority by the General Assembly to determine whether and how to exercise that authority in order to comply with the requirements of an enacted bill. Furthermore, LSA staff who conducted these analyses may not have the level of expertise regarding the intricacies of each agency's rulemaking authority that agency personnel do. Dialogue with agency personnel regarding these analyses is ongoing.

Therefore, the results of the LSA's analysis should not be viewed as binding upon executive branch agencies. The input of agencies referenced in this report should be considered when interpreting the findings of this report. Agency personnel may interpret the language of a bill differently than the LSA does.

Findings of LSA rulemaking analysis

For a brief overview of the findings of this report, see Appendix A. During the 2020 legislative session, 122 bills were enacted. Thirty five bills, or 28.7% of the total, were determined not to involve rulemaking (see Appendix B). Thirty bills, or 24.6%, were determined to authorize, but not require, rulemaking or to have possible implications that may or may not involve rulemaking (see Appendix C). This category includes bills that authorize rulemaking. This category also includes bills for which the LSA was unable to clearly determine whether rulemaking might be required and thus may include bills for which an agency may determine that rulemaking is required. Fifty seven bills, or 46.7%, were determined to require rulemaking by one or more executive branch agencies (see Appendix D).

The degree of rulemaking necessary to implement a bill will vary depending on the language of the bill in question when read in its full statutory context. Some bills require agencies to conduct new policymaking, while others merely require updating rule language rendered obsolete by statutory changes. For purposes of these analyses, bills that do not on their face

require rulemaking, but that do require rulemaking when examined within their statutory context, were determined to require rulemaking. Additionally, bills that do not specifically require rulemaking but that have the effect of rendering existing rules obsolete were deemed to require rulemaking in order to ensure that rules are kept up to date.

Of the 57 bills that were determined to require rulemaking by one or more executive branch agencies, the rulemaking process has begun or concluded, or an agency response has been received, for 44 bills as of April 08, 2021. Three additional bills have delayed effective dates or similar provisions that permit the agencies additional time for implementation. The 13 bills for which rulemaking has not yet begun or for which agency feedback has not yet been received (see Appendix E) include any bill for which at least one instance of required rulemaking has not yet begun. Agencies that have not completed all required rulemaking for 2020 bills are listed in Appendix F.

An individual chart for each bill that was determined to require rulemaking and for which the rulemaking process has not begun or for which formal agency feedback has not yet been received is included separately in Appendix G.

Statutory Requirement to Begin Rulemaking within 180 Days or to Notify the ARRC Iowa Code §17A.4(9) requires agencies to take one of two possible actions regarding rulemaking required by newly enacted bills. Within 180 days of the effective date of a provision of a bill that requires rulemaking, an agency must either (1) begin the rulemaking process by submitting a notice of intended action to the administrative rules coordinator or (2) submit a notification to the ARRC that explains why the rulemaking process has not yet begun. The notification must include all of the following:

- A citation of the provision of the bill for which rulemaking is required.
- The subject matter of the provision.
- An explanation of the delay in beginning rulemaking.
- An estimated timeline for beginning rulemaking.

Such notifications, or other relevant agency feedback, have not yet been received by the ARRC for 13 bills from the 2020 legislative session for which the rulemaking process for all required rulemaking has not yet begun and which have been determined by the LSA to require rulemaking. A bill found to require rulemaking will generally be governed by the requirements of §17A.4(9).
